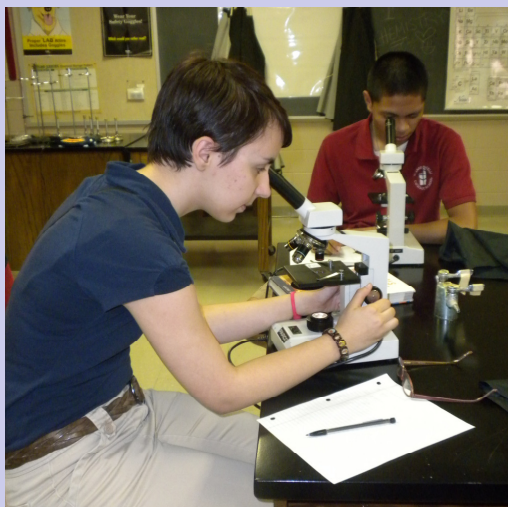

Our students regularly win or place in academic competitions and our standardized test scores are consistently in the top 25% in the nation. St. Anne-Pacelli Highlights

The average St. Anne-Pacelli 5th grade student reads at a 10th grade level and demonstrates math skills at an 8th grade level as determined by the 2011 Terra Nova standardized test.

The average St. Anne-Pacelli 8th grade student reads at a 12th grade level and demonstrates math skills at an 11th grade level as determined by the 2011 Terra Nova standardized test.

St. Anne-Pacelli has the only area Rotary Interact Club (an international service organization) and the only Portuguese Honor Society in the state of Georgia.

Our high school offers 19 honors and 10 AP courses as well as 8 foreign languages. Middle school offers an advanced math program allowing qualified students to take high school level math courses while still in middle school.

Frequently Asked Questions

Why does St. Anne-Pacelli have an Annual Fund?
